It is with immense pleasure that we welcome you to the Maryland State Child Care Association for the 2024 calendar year. MSCCA is delighted to have you as a member and is most grateful for your commitment to professional, licensed, quality child care and education!

MSCCA understands your issues and helps to elevate your voices at the local, state, and federal levels. We have worked hard to share the concerns, barriers and challenges of the industry as well as highlight the successes to impact change when we can. We are so proud to stand for child care programs and early childhood educators because you have proven what we already know, how critical your services/businesses are to children, families, and the economy of our state.

WE are here to help advocate, support professional development and be a strong voice for you in Maryland. MSCCA's Priorities Agenda include, expanding access to quality child care through direct family investments, especially related to Child Care Scholarship Program and child care business tax credits. MSCCA prioritizes reducing barriers related to regulations, addressing the critical workforce shortages, identifying strategies to improve compensation. We know the workforce continues workforce development, and ensuring the community-based programs are recognized and supported related to the Blueprint for Maryland's Future expansion of universal PreK.

It is our goal to supply superior membership benefits and expand benefits for members to best serve your needs and interests. The 2024 annual dues reflect an overall increase of 5% from 2023.

The required monthly fee for the Professional Advocacy Government Relations Lobbyist has increased to meet the costs of the lobbying fees of Compass Advocacy in Annapolis Maryland, which are \$44,000 annually. We divide the number of members by the annual cost to determine the required advocacy fees.

Your membership also includes membership of our national affiliate, the National Child Care Association. The annual fee has stayed the same at \$16.00. The membership certificates for 2024 will include both MSCCA state and NCCA national logos.

Advocacy is an important part of MSCCA's membership benefits and mission. We enjoyed important legislative successes in 2023 that directly impact your businesses. The need for an Executive Director, for Board Members, member leaders and our legislative task force along with a dedicated, professional lobbyist is important to represent child care programs, businesses throughout the year and especially during legislative session. MSCCA has increased the advocacy benefits to include a new muster platform which will allow our members and families to engage with legislators, policy, and decision makers in an impactful way. Advocacy and support from professional lobbyists have proven a successful investment.
