New Business:

Office of Child Care Advisory Council meeting Aug. 17, 2023- See agenda

Carolina, at the meeting too. Chris said they shared Branch updates and scholarship, excels, credentialing and licensing updates. Excels increasing bonuses, making some changes to the standards.revising down to 23 categories and standards, more streamlined. will include higher bonuses at 3,4,and 5. Will share powerpoint. Timeline - some July 1, still pending approval on Standards, and bonuses are budgeted through Blueprint. at start, in 2013 had 331, programs, today over 4000 participating. details in powerpoint slide. MD Excels toolkit available and a new document, to help move through the levels. will share with members on website. New Licensing regulations, regarding new Cannabis law. defines cannabis and includes vaping can not be done on premises. Medical cannabis covered by Health Dept. Other addition is safe sleep practices, included no weighted blankets, swaddling under 12 mos. Clarified That inclined position is not allowed for under 12 mos. Need health care professional to allow inclined position. Law says no Cannabis dispensary within 500 ft , and flip, can't open Center within 500 ft of established Dispensary. Can put cannabis policy in handbook. Final new regulation, family child care should now beagle to apply for non public.

Virginia study showed positive impact of retention bonuses, Maryland will follow suit with survey to Maryland providers. Plan is to implement annual bonuses. ECXTRA Early Childhood Teacher Retention

From Board of Education meeting reviewed Cost modeling for sliding scale for Public preK - will share power point.It looks like we will have many more families eligible for Public pre k 3 and 4 yr olds.

New Prek-Capacity Building Grants (PreK CBG)-

Discussed possible opportunity for MSCCA - Mtg with Dr Cook, for building to be a PreK site. Would MSCCA be interested in applying to the Grant with qualified programs as a support to the applicants throughout the year?. Grant application for this needs to be in by Sept 8.

Purpose of the grant is to increase the number of community based programs that will participate in Blueprint. They have lowered the entry point to get programs started. Lead teachers only need to have a degree for PreK CBG, For PreK Grant teachers need to be working towards alt cert pathway, praxis, and need a MCPS internship. What is the timeline? Funding would be for this school year. Applications reviewed as they receive them, issue notification of award within 30 days, can apply now for the children already on your program that meets one of three requirements. Language/Special needs/Income. Should MSCCA apply to be a vendor to support a limited number of member programs through the PreK capacity grant application?

We could tentatively move forward to develop a pilot plan with 2 or 3 programs, write a grant proposal for MSCCA support and coaching for Child Care programs interested in qualifying for the PreK Capacity grant. This could be the first opportunity to test if it will work.

MOTION 2:by Deb - Move forward to develop a pilot plan and write a grant proposal for MSCCA to act as an approved Vendor, working with 2-3 qualified programs to provide support and coaching throughout the year for the PreK Capacity building Grant. Second Cindy.

Discussion - none.

Vote- 8 in person in favor, Randi abstain. Imani Abstain. remaining online in favor. Motion has passed.

Aug 1 - Ruth and Chris met with Congr. Sarbanes to discuss scholarship. He said it would be great to have a federal apprenticeship program piloted by maryland. Grant application is similar to state application grant. Environmental Grants - Lead remediation grants available through dept of housing for child care . Lead testing threshold has been lowered, which could impact schools with follow up testing. so it may be a good conference session.

New Child Care Bonuses

Child Care Scholarships- Presumptive Eligibility across state

Shared concerns sent to MSCCA, parent's hearing there is no funding. They do have money, and are addressing removing that info. Presumptive eligibility is a 3 day turn around. Looking for feedback

Harford County Chapter affiliation with MSCCA and changes in leadership Janelle resigned in Jan, not renewing MSCCA membership. She is starting unaffiliated Director's association. Looking to reach out to establish a new connection and keep the chapter.

Legislative - Legislative Task Force, Public Policy & Program Oversight and Regulations: Carolina Reyes, Member at Large, Chair Carolina - partnering with Head start - pay by head start, then can obtain Maryland CCS at full rate. if this is true, would be very helpful for centers. Not confirmed. would allow full day of care for head start students.

Media- Baltimore Banner and Washington Post contacted Chris Peusch about numerous issues. Child Care Scholarship concerns and delays, Montessori program closed by licensing. I gave background and data to all reporters and introduced them to Board Members in their catchment area to provide stakeholder feedback for the articles.

Congressman John Sarbanes reached out to Chris Peusch, MSCCA to meet about child care issues in Maryland. He was interested in Anne Arundel County programs and I solicited Ruthie Claytor and Lisa Buchy (Ruthie also invited chapter members) and met to provide data, problems and solutions)

Chris Peusch, MSCCA asked to participate on a panel at the Maryland Association of Counties Conference on August 19, 2023- see slides attached

Chris Peusch attended the Pillar 1 Blueprint meeting as a guest to share concerns about the Blueprint inequities and recommendations What priorities do you want to focus on with OCC, all MSDE branches, workforce issues, legislation-2024, Blueprint Pillar 1

Administration and Bylaws Committee- Chair/s Barry Benesch and Imani-Angela Rose

<u>Membership and Membership Services</u>- Chair/s -Chuck Wainwright, Lisa Dickinson, Caitlin Holley- membership list and data - we have well recovered from pre-covid levels. Prorating effective June 30, prorate by how many months remaining. NOTE - ByLaws committeereview the Prorated Membership benefits and cost.

We had a limitation of 10 family child care members, this was not meant to deter individual members. Discussion - we do not want to restrict membership growth, By Laws committee should review the membership classifications. Family center

Motion 3: Recommend to ByLaws committee to create a new membership category called family provider member, no more than 10% total membership. ByLaws committee will then recommend back to the board what new category and rights will be. Seconded by Barry. Vote - all in favor in room and online. Motion Passed
