Welcome Guests: Cindy Lehnhoff and Jessica Gobble-Reil from nation affiliate-National Child Care Association and National Early Childhood Program Accreditation

Cindy Lehnhoff - Director of National Child cAre association and Jessica GobbelReil of NEPCA as manager of quality and development who has merged with the NCCA. JEssica focused on helping programs get staff credentialed on a national level. Help with staffing, very available. NEPCA starting new partnership with Maryland Family Network. Cindy L, was provider, went through accreditation process. NCCA goals is to connect organization together, at federal and state levels, to develop unified way to work with legislators. partnered with ECEC - Early Childhood Educ Consortium. Worked on what every childcare provider needs to be asking for, especially small providers. Senate committee recommendation for next budget reflects most areas getting a cut - but child care development block grant is fully funded. Will add 7 Mil to block grant. NCCA is asking ASsociations to sign on to support this request.

Legislative agenda 2024~New advocacy engagement-Chris Peusch- see attached Bill priorities Chris/Carolina/Randi:

Close to 7 bills sponsored, HB 662 - to lower Lead teacher age to 18, looks like it will pass. Several people sent testimony, Chris testified.

Evening in Annapolis - went very well, so well organized. First time since Covid. Attendees were very excited to speak with their legislators. Lisa thanked Board members who attended. Feedback: Carolina - very excited to be a part of the advocacy and particularly wanted to thank Chris for an amazing job organizing and leading at this great event. Deborah W commented that her experience was great first time meeting her representative and speaking to the needs of PG county. Bus transportation was very helpful, they used Rand R in PG - MSCCA should look to support this partnership for future events for more chapters.

Chris will be sending more info on Bills out. Board members will be testifying. HB600 altering CCCPDF - changing the min hours of service afterwards to 20 hrs/wk. included an equity component to make sure providers can access CCCPDF in native language. New to college students would get priority. No waitlists for these colleges so we need to expand access and use. HB 1455 - Del Solomon, Pub Prek, Waiver ACtion plan and Hubs.HB 1441, and HB 1385. these help change the landscape of the Prek Expansion grant, to help reduce the barriers. Randi- 1441- 2 pathways - looking at experience in addition to an AA, gives some leeway in hiring teachers within the blueprint grant. More programs can participate. recommend

Assistant teacher language be changed away from CDA, since public school requires CDA for their assistants. Recommend "Working towards Level 5 or 6" to avoid being in direct competition with public school hiring. HB 1385 to create equity between child care and public school as far as requirements and pathways to certification for teachers in child care prek.

BOE meeting tonight - Chris sending out Link by email!

MSCCA Lead Agency on new initiative approved by Board- grant writing support for public PreK Children's Opportunity Alliance of Montgomery County partnership with MSCCA and Aspire

Services directly to the program - Writing the grant, and keeping to timelines. Current funding does not provide additional support to help programs work with MSDE. Current funding does open the door for more programs to participate in blueprint. When the sliding scale opens up to more families in state, we can be ready to support more programs. This could be a pilot for MSCCA to expand and be able to serve programs in other counties moving forward. Moving toward Blueprint Formula Funding for FY 26 which is a transition year. Tier 2 should start with PreK Grant for this year.

MSCCA splitting costs and resources with the Alliance. Randi proposes that a portion of the money allocated for the 50/50 split between AspireAlliance and MSCCA. that a portion of the amount goes to pay for Chris , since this is over and above the regular work in Exec Direct job description. Chris for the record, did not request any extra funds. Randi clarified that so far Chris has worked on this without pay. Ruthi clarified that hours worked hours paid in MD - not in job description. Chris should be paid.

MOTION 3: Randi - To allocate a percent of funds from the external PReK grant to pay the executive director for work completed that is outside of scope her regular job description. Carolina second: Vote passes.

Possible Paid Intern discussion - discussed several times to support Chris with an intern. Look to start with about \$3600 of budget. \$20/hr. Potential intern to have child care, admin and social media skills. Lisa as MSCCA Chair establishing a search committee for this committee, Ruthi has accepted Chair position for the search committee. Chris looking for - monthly newsletters w/ legislative corner, Conference registration, vouchers, data management, probably not a board member, as a conflict of interest. receiving paid since most of these activities are also part of board duties.

MOTION 4: Astrid: Create a Paid Internship position to assist Exec Director with monthly communications, conference data management. at \$3600 per year. Second Ruthi Vote passed.
